May 13-14: USD SEC Reg Senior Notes Offering May Follow

Trinity Capital Inc. (the "Company", ticker "TRIN") has requested KBW and MUFG to arrange a series of fixed income update calls for Wednesday, May 13th and Thursday, May 14th. A virtual presentation has been made available in advance of the calls. A USD-denominated, SEC-Registered senior unsecured notes offering may follow, subject to market conditions. Trinity Capital Inc. has senior unsecured ratings* of Baa3 (stable) from Moody's Rating Agency, BBB (stable) from Egan-Jones, and BBBL (stable) from Morningstar DBRS.
